1. The applicant College is having good infrastructure with all the basic facilities.
2. The locality possesses the ability to feed the students for the applicant college.
3. The management has identified the Principal and required faculty members and the Physical Education Director for the 5 years B.A.,LL.B course and received the consent letters from them.
4. The applicant college has already set up a Moot Court Hall, and has separate room for NSS and Sports.
5. The institution has shown common library and not established a separate library for the law college.
6. There is already a provision for girl's hostel in the campus.
7. The institution has huge common play ground which is also accessible to the applicant college students.
8. The proposed principal has submitted the thesis to the Criminology Department, Rani Chennamma University, Belagavi and has not yet been awarded with the Ph.D degree.

IX. CONDITIONS TO BE FULFILLED

- 1 The applicant Institution has to obtain the approval from the Government and the BCI before admitting the students.
- 2 The proposed principal should obtain the Ph.D degree before the confirmation of his appointment.
- 3 The management should establish a separate well equipped library exclusively for the law college with sufficient number of law and non law books, periodicals and journals.
- 4 The faculty members appointed on full time basis to the applicant college for law subjects must surrender their *sanad* immediately on the confirmation of their appointment.
- 5 Depending on the major and minor pre-law subject offered by the proposed Law college, a full time faculty for that subject must be appointed.

X. RECOMMENDATION:


